

2018 GROOMING TENT AGREEMENT

(MUST HAVE SEPARATE FORMS FOR EACH GROOMING TENT REQUEST)

*You may obtain a Grooming Chute permit at the fair office for either \$25 for 10' depth or \$50 for 20' depth depending on size of your canopy. Grooming lots are available on a first come first serve basis. Permits will go on sale starting June 4th at the fair office during regular business hours. Only families with Junior Fair large animal entries are eligible to rent lots. Large animal entries include, Beef, Dairy Beef, Beef Breeding, multiple sheep, multiple goat or any combination of those listed. Grooming lots will be open at 3:00 P.M. Friday July 27. You must pick up your permit in advance to setting canopy or grooming chute. Mail or bring this form to the fair office with full payment. **A separate form must be filled out for each tent spot requested.** Checks are written to Medina County Fair.*

I, _____ agree to hold harmless the Medina County Agricultural Society from any claim, demand, suit, loss, cost of expense, or any damage which may be asserted, claimed or recovered against or from Medina County Agricultural Society by reason of any damage to property, personal injury or bodily injury, including death, sustained by any person whomsoever and which damage, injury, or death, arising out of my use of grooming tents at this facility.

RULES:

1. Space fees do not include fair entry. Everyone using grooming chutes must have and hold a ticket for the week of the fair. Tickets must be membership ticket, season, ticket, Jr. Fair pass or Jr. Fair advisor ticket.
 2. You must be age 18 or older to reserve a grooming lot in your name. The renter is responsible for all activities that occur in the grooming tent.
 3. Overnight stays are not permitted. Grooming tents must be vacated each night at the close of the fair.
 4. Grooming tents can be shared by multiple families but not be sub-leased.
 5. Grooming tents must be kept in a clean and orderly condition. NO alcoholic beverages or illegal drugs are permitted.
 6. Health and fire codes must be respected and observed. This includes NO OPEN FIRES.
 7. No FAIR OWNED picnic tables, benches, tables or chairs are permitted to be used inside grooming tents.
 8. Grooming permits must be displayed in a place visible on the east side of canopy.
 9. No vehicles, campers or trailers are to be parked in the grooming tent area.
 10. Per Ohio Fire Code 1301:7-7-24
- A: Tents must be flame retardant and have documentation.
B: Tents must follow manufactures requirements to be adequately roped, brace and anchored to withstand the elements of the weather and prevent against collapsing. Each leg of the tent must be secured with weights or staked with a force equaling 25 to 40lbs. Weights can either be attached to each leg of the tent or securely tied to all 4 sides of the tent frame with the weight resting on the ground.
11. Tents are permitted to have sides and a back. Front of canopy must be left open during fair hours and while occupied. Canopies must be open clear space from front to back. No subdividing, rooms inside of rooms or false backs will be permitted.
 12. Canopy sizes can be either 10' by 10' or 10' by 20' depending on lot size.
 13. Electricity will be provided by the Medina County Fair within 50' of each lot. Electricity is to be shared between all grooming tents. Extension cords will not be provided and must be used in a manner that does not create a hazard. **Portable generators will not be permitted on grounds.**
 14. All lots need to be cleaned up no later than Monday August 6th 9pm.
 15. Persons not abiding by the rules will have their contract canceled, and will be removed from the grooming area with no refund.
 16. The Medina County Agricultural Society reserves the right to cancel a lot contract at any time or refuse or reject any application and will not be responsible for any accidents of any sort.
