

2024 Rabbit Project Exhibitors

Important Dates & Deadlines

To exhibit your rabbit at the Medina County Fair, check that you have enrolled in the correct project. Breeding Rabbit –stays at fair, rabbits judged in appropriate breed class, also includes doe & litter class.

Market Rabbit-stays at fair, rabbits are judged as a pen of three, also includes fryer class. Quality Assurance is required to exhibit this project.

Pet Rabbit-does not stay at fair (still exhibit project) rabbits are judged at pre-fair judging and goes home. Poster or scrapbook stays for exhibition. Pet Rabbit division winners may be eligible for State Fair participation on Companion Animal Day.

Please make special note of these dates and events. Parents are requested to stay with the 4-H'er at clinics.

- May 1 Single Breed Rabbits must be in member's possession.
- June 1 Quality Assurance Training Deadline
- June 1 ALL Junior Fair Livestock & Junior Fair Pet Animal Entries DUE by 5:00 pm in the Extension Office
- June 15 Fun Show – 8:30 am, MFG-Building #22, more information will be available after May 1st.
