

2024 Dog Agility Project Exhibitors Important Dates & Deadlines

Please Note: Completion of Skillathon is required for dog project: 201P.

- January 30** All project dogs must be born on or before this date.
- March 12** Dog Project Orientation – 7:00 pm, Medina County Extension Office
- April 1** Project animal must be in member's possession.
- April 9** ****Dog Agility Obedience Assessment – 7:00-9:00 pm, MCCC, O.C. Duke-Doggie Day Care Room**
MANDATORY- for ALL 1st-year agility exhibitors and returning youth planning to show a new dog.
This will be the only Obedience Assessment for Dog Agility-201P.
- May 7** Practice begins for all agility members – at 7:00 pm at the Weigel's Farm, 7795 Center Road, Valley City
Practices are weather permitting. Check with a committee member if in doubt.
IMPORTANT REMINDER: Parent/Legal Guardian must be present. Proof of Vaccination and Permission to Participate must be presented at the first practice attended.
- June 1** **FORMS DUE** by 5:00 pm, with your entries in Fair Entry: **4-H Certificate of Vaccination** and **Permission to Participate in Ohio 4-H Dog Activities**. **These are your animal entry forms for the fair.** ****Forms received after June 1, are LATE.**
- June 17** Deadline for State Dog Agility Trail. Entries must be posted and marked by June 17th. **NO LATE ENTRIES ARE ACCEPTED!** Mail Entry form and check to Ohio 4-H Agility, Nationwide & Ohio Farm Bureau 4-H Center, 2201 Fred Taylor Drive, Co
- July 11** **Skillathon – 6:30 pm, Medina County Extension office** *Required for members enrolled in 201-O, 201-S, 201-P, and 201-W (Bring a snack to share!)* **For members enrolled in Dog Agility-Project Record Books are Due Today!**
- July 12** **Request for July 18 Dog Skillathon Make-up due by 5:00 pm to Medina County Extension Office**
- July 18** **Makeup Date for Skillathon – 6:00 pm, MFG Pavilion.** Appointments for Skillathon Make-up by prior request.
- July 29- August 4 MEDINA COUNTY FAIR**
- August 1** **Medina County Jr. Fair Dog Agility Show – 7:00 pm, Fairgrounds.** Please arrive at 5:30 pm and only use GATE 4 with your dog. A gate pass is on the back side of this page.

Monday, July 29 – Dog Show

(Check-in 5:30 pm-6:00 pm – show starts at 6:00 pm)

Thursday, August 1 – Dog Agility

(Check-in 5:30 pm – show starts at 7:00 pm)

All Jr. Fair Exhibitors and their dogs must stay in the Red Show Barn Area. Exhibitors and their dogs are not allowed to walk through the midway or livestock barns before, during, or after the Dog Agility Show.
