Campership/Event Scholarship Guidelines

Camperships (scholarships to assist youth in paying camp fees) and older youth opportunity scholarships are available to Medina County 4-H members through donations from local sponsors. Camp is open to youth currently in the third grade to eighth grade. Please complete the following information and submit to our office by **5:00 pm May 1st**.

For Kelleys Island, due with this form is a \$20 deposit.

For all other camps, due with this form is a \$20 deposit.

For other scholarship, please write amount requesting on designated line.

Application Process:

1. Complete one form for each youth. All information must be complete to be considered for a campership or scholarship. **An incomplete form will not be considered.**
2. **Late applications will not be considered.**
3. Submit Camper Registration form and \$20 deposit per camper Kelleys Island only or \$20.00 for other camps. If deposit is an issue please contact the extension office.
4. Campership and Scholarship funds will only be awarded for the individual named on the application. Awards must be used for the 2024 program.
5. Priority will be given to families with financial needs, where children would not be able to attend camp or event without scholarship support. This includes families with multiple children who would be unable to send all siblings to camp or events due to cost, members from low socio-economic homes, and families who have extenuating financial circumstances.
6. County 4-H Advisory Scholarship and Award Committee will review applications. All information on the application will be kept confidential. Notice of camperships will be sent via e-mail by May 13th. **Please print legibly.** If no e-mail address is provided on the application, recipients will be notified by phone.
7. If full or partial payment has already been made towards camp or event, and the camper is selected to receive a campership or scholarship, a refund will be provided to the payee if applicable.
